Notes	Promoter and Promoter Group: During the quarter ended 31 December 2025, the National Company Law Tribunal, Bengaluru Bench vide its order under Section 232 of the Companies Act, 2013 dated 29 October 2025, has approved the Scheme of Amalgamation between Euro Industrial Enterprises Private Limited, Sandur Sales and Services Private Limited, Sandur Udyog Private Limited (collectively, Transferor Companies) and Lohagiri Industrials Private Limited (Transferee Company), all forming part of the Promoter Group of the Company. As per the aforesaid Scheme, the shareholding of the Transferor Companies were transferred to the Transferee Company on 15 December 2025, with no change in the aggregate shareholding of the Promoter Group and the total number of Promoter and Promoter Group reduced from 14 to 11. SBO: As a result of the aforesaid merger, the percentage of shares (direct and indirect) held by Bahirji Ajai Ghorpade, Significant Beneficial Owner increased from 14% to 21.66% on 15 December 2025.
